## STAP info for MSc Health Economics

- offered by the WiSo Faculty within their worldwide partner schools network
- including ERASMUS cooperations
- offers one term abroad with exempt of tuition fees
- offers full options for credit transfer
- main selection round in fall:
  - 1 December 2023 - 15 January 2024
  - accepts application for either fall 2024 or spring 2025 (full offer !)
- secondary selection round in spring (if offered at all)
  - accepts application for spring 2025 (very reduced offer)
- uses the WEX (WiSo Exchange) database as information and application tool
- requests an English certificate (TOEFL, IELTS or Cambridge Certificate)
- manual for STAP Master applications available on ZIB homepage

## Two options for credit transfer (only ECTS – no transfer of grades)

- Course-to-course
- Modules ‚Studies Abroad‘

### Course to course credit transfer

- strict restrictions on content, workload and type of exam  
i.e. ca. equivalent/comparable to the module of your Cologne degree
- individual academic counselling needed
- advise offered by WiSo Anrechnungszentrum (only after admittance at the host school)

### Modules Studies Abroad

- offers broad course opportunities
- for MSc Health Economics up to 30 ECTS
- advise offered by the ZIB coordinator
  - > **general rules** (for all study courses at Master level)
  - > **specific rules** (for individual study courses)

## Modules ,studies abroad‘ **general rules** (same rules for all study courses at Master level)



only courses at graduate level (with WiSo focus)



only courses with exam, grade and credits (*listed on a transcript by your host school*)

- **no** ,introductory..‘-courses (see: course title), *pls check with ZIB*
- **no** MSc courses already taken at UoCologne
- **no** Bachelor courses  
(in case of 4 yr Bachelor courses, pls check level with ZIB coordinator)
- **no** attendance only courses (i.e. skills seminars without exams, ...)
- **no** language

## STAP Programme, offered by the WiSo faculty

- > for Master students only available within regular study period, **i.e. application in your first MSc term required**
- > listing partner schools per study course with course offer suitable for credit transfer for the modules ‚studies abroad‘

Your applicant group **STAP MBA/MSc Business & Economics** which includes:

- **MBA schools: request work experience (*min. 6 months full time or more*)**  
pre-defined course selection, focus on management practices, focus on in-class discussions and project works, MBA cohort with a variety of professional backgrounds
- **MSc schools: no work experience required:**  
broad selection of courses or specialisation tracks, academic focus will include as well case studies,



**selection criteria:**

61% - Bachelor\* final grade

9% - Admission test (TM Wiso, GMAT, GRE)

-> *not compulsory! We accept tests taken for admission to Master studies or on a voluntary basis*

30% - Evaluation CV (internships, extracurricular activities...) & letter of motivation/study plan



**one ranking list for all applicants within the STAP MBA/MSc Business&Economics**  
for fall 2024  
for spring 2025

\* 61% – current MSc grade, only for 2nd yr. MSc students (*STAP applications only accepted in case of longer internships, illness or any extraordinary circumstances*)

### Term dates

-> **for which term abroad (fall or spring) you want to apply**  
*in case of conflict with Cologne term dates (some students combine with an internship ...)*

### Subject areas

-> **remember the credit transfer options**  
*watch out for subject area ,Business'. in case of subject area ,Economics only': pls check yr  
academic experiences in Economics courses*

### Study requirements

-> **important infos on course options**  
*only listed if there is any additional information/requirement*

### Language requirements

-> **if there any additional\* requirements (to the STAP application requirement)**  
*- in case of higher (C1) English skills (needs to be presented with STAP application)*  
*- in case of language skills other than English (ca. B1 with application -> with need to  
improvement to reach ca. B2-level (before start of term abroad)*

### Work experience

-> **if more than 6 months expected** *pls discuss with ZIB coordinator, whether your profile meets the expectations for work experience for your preferred host school, have your latest CV available.*

### Fact sheets

-> **infos on expenses, accommodation, courses etc.**  
*we will upload most recent factsheets when they are sent to us by partner schools*

### Conversion rate

-> **only listed for schools not applying the ECTS system**  
*conversion rate from local credits to Cologne credits*

### funding

-> **if ERASMUS mobility grant offered**  
*for schools without an ERASMUS mobility grant, applications for grants will be available after our selection round.*

### Experience reports

-> **experience reports, fall & spring reports in one file**  
*reflects individual experiences, pay special attention on the term/info on accommodation may give an idea on number of slots (may differ each year/term)*

## STAP MBA/MSc Business & Economics: how to prepare

- **check your Cologne study plan:** modules ,studies abroad‘ (see your course catalogue) keep the area open
- **check your English certificate**  
we accept TOEFL (min 87), IELTS (min 6.0), Cambridge Certificates (min. FCE) older than 2 years  
Only in case the partner school does not accept the old test a new test will be necessary  
(only applies after communication of selection results, ca mid February)
- **check your financial resources available for a term abroad**  
although tuition fees are exempt, you need to be aware of costs for a term abroad, the level of costs differs significantly depending on choice of school, country, city  
**working student position:** don't expect to keep your working student position during a term abroad via remote/home office.
- **check your CV and collect all documentations**
- **discuss your work experience with the ZIB coordinator if interested in an MBA school**

## STAP MBA/MSc Business & Economics: your application

### for which term abroad? fall 2024 or spring 2025?

-> watch out for term dates, study regulations, experience reports ...). If term dates do not fit (what about an internship)

### for which schools abroad? *(final list of schools only available on 1 December)*

-> watch out for subject area, study/work/language regulations ...)

### for how many schools abroad?

- > less than 5 schools. If you are only interested in specific schools and not interested in other schools
- > 5 schools. In case of no direct offer for any of your listed 5 schools: a list of alternative offers could become available (only if overall slot capacities allow)

### for how many applications per student?

-> **just one! once submitted – no alterations possible!** Only complete applications with all the required documents and submitted before the final deadline can be considered for the selection process

**„STAP Master Main Selection“** for academic year 2024/25

opens on **1 December 2023** (new WEX section: ‚my applications‘). Your application

-> **new WEX section: ‚my applications/my personal data‘**

- enter your personal data/study data
- start your application
- select/start your applicant group (MBA/MSc Business & Economics .. *fall 2024 or spring 2025*)
- select your preferred list of schools
- **start** uploading your application documents

**Until final submission** of your application, you may just leave and re-enter the database, change your preferred list of schools, re-read your application documents, exchange your application documents until final submission.

**Once submitted – no alterations possible!**

**closes on 15 January 2024 (= final deadline)**

## 1. document ,personal data‘

- letter of motivation/study plan -> for your highest ranked school, pls mainly focus on academic aspects *pls see STAP Application Manual*
- your latest CV (in English) -> pls put much emphasis on correct data and chronology, *pls see as well STAP Master Application Manual*
- proof of English skills -> either TOEFL **iBT** 87, IELTS 6.0 (academic), Cambridge certificate, FCE, or Bachelor degree fully (= 100%) taught in English.  
-> certificates older than 2 years are accepted for the STAP application (pls see further info in STAP Application Manual)
- proof of further language skills -> only if requested by (*one of*) your listed schools, self-evaluation form (*available through the online STAP Master Application Manual*)

## 2. document ,study details‘

- Bachelor degree
    - > *certificate only, no module descriptions, no diploma supplement*
    - > if not available yet, official document listing your final BSc grade
      - > *for Bachelor degrees taken abroad, pls include the letter of uni-assist showing your German gpa equivalent (if available)\**
  - Admission test
    - > not compulsory
    - > *we accept admission tests (GMAT, TM WiSO, GRE) either taken for admission to master studies or on a voluntary basis*
  - Proof of Enrolment
    - > download through KLIPS (no student card)
- 
- *MSc transcript of current Cologne studies*
    - > *only applies for 2nd term/advanced MSc students (on exceptional cases)*

*\* this helps with processing the application. If this is missing in application files, we will still accept the application. We will get in contact with the respective students*



### 3. document ,professional data‘

- *pls use the documents in the language available, no translation into English or German necessary.*
- *pls compile the documents in the same chronological order as listed in the CV*

#### records of internships, subject related activities as listed in CV

*-> references for recent internships (not for internships during school time)*

*-> if no reference available yet, pls check if other documents are available instead (this could be extract of work contract (only showing name of company, place of internship, your name, type of internship, period of internship and signatures (you may black-out the rest of the document)*

#### records of extracurricular activities

*-> if available*

*-> if not available, pls upload a document listing the organisations‘ website, name of contact person*

General Infos

- Academic Short Programme in New York
- Six weeks: begin August – mid September 2024
- Credit options: yes / study course
- Contribution to expenses required

Application

- Through WEX-database in December/January
- Parallel applications for WiSo@NYC and STAP are possible\*

\*NOTE: If both applications are successful, you will need to choose one offer

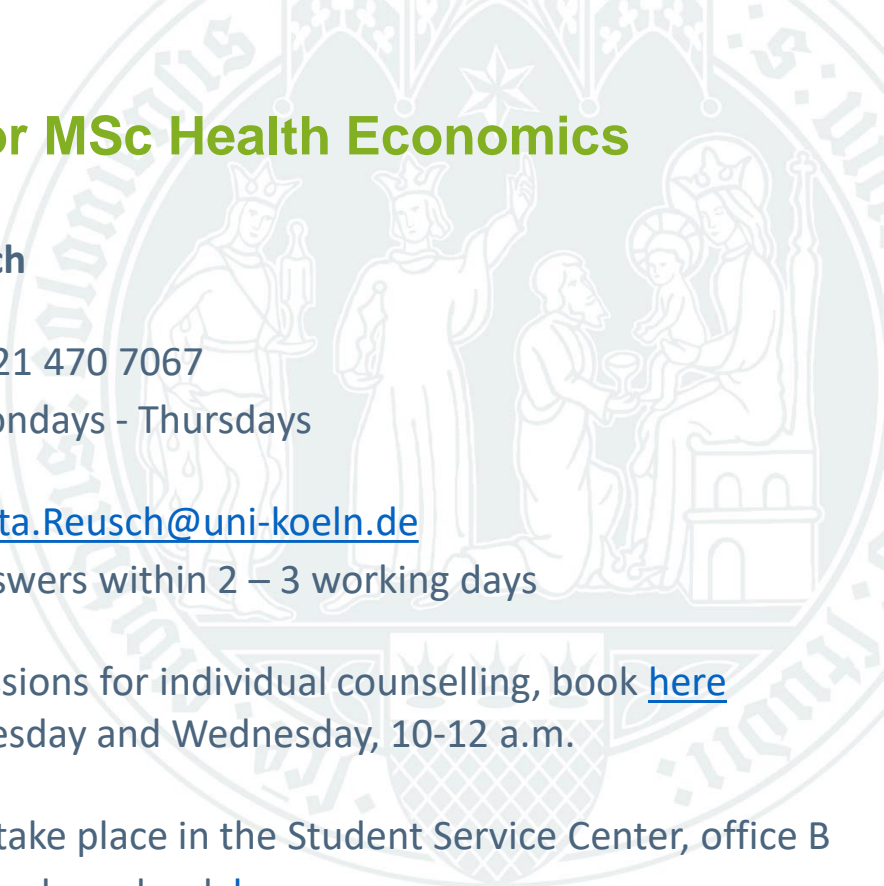
